Mirapoint has made email archiving an order of magnitude easier and more cost effective with ComplianceVault™, which includes everything you need to archive your email – including application software, server hardware and storage system, all in one easy-to-deploy appliance. Mirapoint's ComplianceVault passively and discretely copies all messages sent or received within an organization, indexes the messages and places them into a permanent archive that is searchable.

Mirapoint's policy-driven email archival approach allows administrators to selectively group messages by division or department, sender and receiver, and external or internal messages only. In addition, Mirapoint's anti-spam and anti-virus technology can be used to greatly reduce the number of messages indexed by blocking these messages at the edge. The entire archival and search process can be conducted securely without alerting or disrupting users. The ComplianceVault's high-speed search capabilities allow reviewers to discover messages based on sender, recipient, subject, keyword and date range. Marked messages can then be securely exported in the common .eml format. The archive message base is not modifiable, and all actions by administrators or by the ComplianceVault itself are recorded in a secure audit log.

## How the Mirapoint ComplianceVault Solution Works

In a simple setup process, special archival journal interfaces are activated on the mail server. A variety of filters can be applied to these interfaces to journal only specific types of messages or to place messages with differing content or headers into different secure folder locations. One or more ComplianceVaults log into these journal folders at pre-set intervals to collect the messages for indexing and storage. Messages indexed and stored in the archival message base can be automatically backed up to tape at regular intervals (typically nightly). Messages on the tape can be secured using private 256-bit encryption. Once the messages are indexed and archived to tape, the original messages are deleted from the archival folder that is on the mail server, completing the archival process.

ComplianceVault combines all of the hardware and software you need for a plug-and-play archival solution into a single appliance. Competitive solutions require you to piece together a solution by buying server hardware, storage, software and operating system separately.

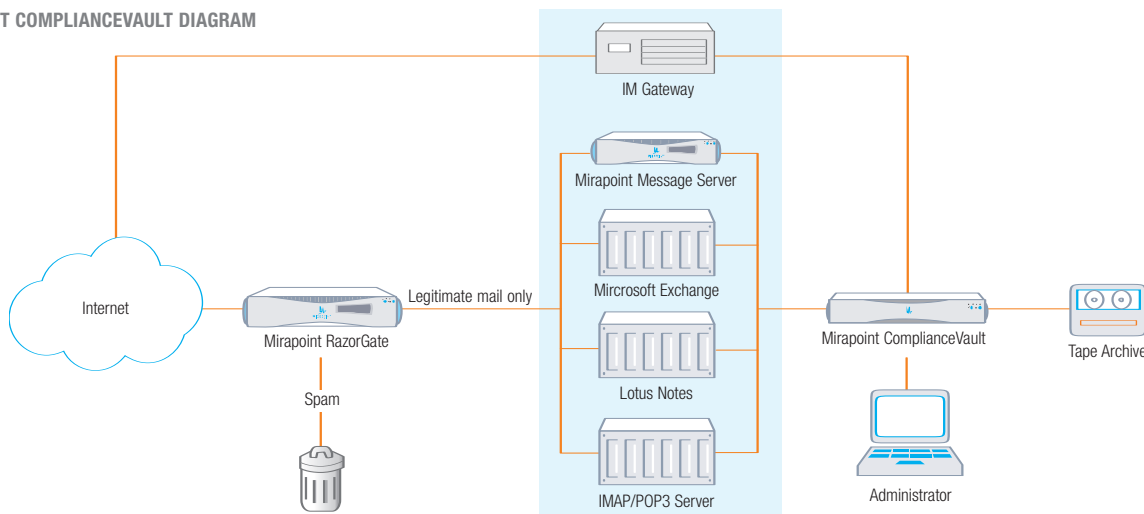
### Multi-platform compatibility
